b. Neil Janz and Jim Swaenepoel – Peacock Issues

Neil Janz and Jim Swaenepoel representing local residents attended the meeting to present issues that are being experienced along Sowden Street in regards to the noise, mess and destruction created by the peacocks. There are a number which roost in trees along Sowden Street every night from April until November (birds are housed in the barn in Victoria Park for the winter months). The peacocks then screech throughout the night not allowing residents to have windows open, or enjoy their yards. The wondering birds leave behind a mess and scratch vehicles and buildings. The troublesome birds will continue to locate in the same area each year. Suggested solutions to the increasing issues is to downsize the population of peacocks by removing (selling and/or relocating) some from Souris, limit the number of hatchings each year. The delegation expressed that the local citizens do not want to see all the peacocks removed from Souris as they are a beautiful attraction for residents and

visitors to the community. Council will contact the Department of Parks and Recreation to discuss a solution for the concerns by local residents.
